NATURE OF THE ACTION.

1. The plaintiff brings this action as against the defendants to obtain a monetary judgment in compensation for personal injuries and other damages arising out of an accident which occurred on March 27, 2014.

JURISDICTION AND VENUE

- 2. This Court has subject matter jurisdiction over the claims in this action pursuant to the provisions of 28 U.S.C. Section 1332.

repair, cleaning of the aforesaid premises.

 were in possession of, used, occupied or were otherwise in control of said premises.
- 11. Upon information and belief, on March 27, 2014 defendant, PLAYERS CLUB AT BREWSTER ICE ARENA, INC. was the owner of premises being known as Brewster Ice Arena with street address 63 Fields Lane Brewster New York 10509.
- 12. Upon information and belief, on March 27, 2014 defendant, PLAYERS CLUB AT BREWSTER ICE ARENA, INC its employees, agents, servants and assigns operated the aforesaid premises.
- 13. Upon information and belief, on March 27, 2014 defendant, PLAYERS CLUB AT BREWSTER ICE ARENA, INC its employees, agents, servants and assigns operated and were responsible for the management, maintenance, inspection, supervision, repair, cleaning of the aforesaid premises.
- 14. Upon information and belief, on March 27, 2014 defendant,
 PLAYERS CLUB AT BREWSTER ICE ARENA, INC its employees, agents, servants
 and assigns were in possession of, used, occupied or were otherwise in control of said
 premises.
- 15. Upon information and belief, on March 27, 2014 defendant, STEVE SANTINI was the owner of premises being known as Brewster lice Arena with street address 63 Fields Lane Brewster New York 10509.

- 16. Upon information and belief, on March 27, 2014 defendant, STEVE SANTINI his employees, agents, servants and assigns operated the aforesaid premises.
- 17. Upon information and belief, on March 27, 2014 defendant, STEVE SANTINI his employees, agents, servants and assigns operated and were responsible for the management, maintenance, inspection, supervision, repair, cleaning of the aforesaid premises.
- 18. Upon information and belief, on March 27, 2014 defendant, STEVE SANTINI his employees, agents, servants and assigns were in possession of, used, occupied or were otherwise in control of said premises.
- 19. On March 27, 2014 plaintiff was an occupant of the above described premises, in particular, the Brewster Ice Arena and on that date and while on those premises was injured when a heavy, large coin change machine fell upon her.
- 20. The accident described above caused the plaintiff to sustain injuries and damages hereinafter described.
- 21. The aforesaid accident with resulting injuries and damage to the plaintiff was the result of the negligence, carelessness and recklessness of the defendants their respective employees, agents, servants and assigns.
- 22. As a result to the above, plaintiff continues to suffer severe and disabling injuries; continues to endure great pain and suffering; continues to expend sums for medical care and treatment; continues to be prevented from engaging in productive work; continues to be unable to engage in and attend to all daily activities, pursuits and

pleasures associated with plaintiff's person and station in life; and remains otherwise rendered sick, sore and lame and disabled all to his damage in a sum within the jurisdictional limits of this Court.

WHEREFORE, Plaintiff respectfully requests that this Court grant the following relief:

- a. An award of monetary damages in favor of the plaintiff as against the defendants jointly and severally under the facts and circumstances together with applicable interest.
- b. An award of costs and expenses of this action together with reasonable attorney's and expert fees; and
 - c. Plaintiff demands a trial by a jury
 - d. Such other and further relief as this Court deems just and proper.
