SIR(S): PLEASE TAKE NOTICE that the claimant herein hereby makes claim and demand against the CITY OF NEW YORK and NEW YORK CITY POLICE DEPARTMENT as follows:

2. The nature of the claim:

To recover damages for mental anguish, loss of personal freedom, harm to reputation, embarrassment, and ridicule sustained by claimant JUNIOR BISHOP, all as a result of the negligence, carelessness and recklessness of the respondent, THE CITY OF NEW YORK and/ THE NEW YORK CITY POLICE DEPARTMENT, and/or their agents, servants, and/or employees, in the negligence, false arrest, false imprisonment, malicious prosecution, and deprivation of civil rights under the Constitution of the State of New York and the Constitution of the United States, as well as other State ordinances, statutes, codes and rules including 42 USC 1981, 1983, 1985 and 28 USC 1345 and for negligent hiring, training and retention of the officers involved in the incident.

3. The time when, the place where, and the manner in which the claim arose:

On July 26, 2014, at approximately 1:45 p.m., the claimant JUNIOR BISHOP, while in costume as Spiderman and lawfully present in front of 1472 Broadway, Times Square, New York, New York was falsely arrested (Arrest # M14681247), taken to the Midtown South Precinct, and then taken to Central Booking, where he was incarcerated through arraignment and imprisonment with the Manhattan Detention Complex ("The Tombs") until his release on or about July 31, 2014, all due to the negligence of the City of New York, the New York City Police Department, their servants, employees, and agents, all to his damage and deprivation of his civil rights. He was then

maliciously prosecuted in the Criminal Court of the City of New York, County of New York, under Docket # 2014NY058049, which prosecuted ended in a dismissal on or about February 3, 2015.

4. The items of damage are:

Damages, include loss of freedom, severe mental anguish, humiliation, reputational harm, psychological trauma, and financial expense all to his detriment in the sum on \$1,500,000.00

The undersigned therefore presents this claim for adjustment and payment, and notifies you that unless the same is adjusted and paid within the time provided by law from the date of its presentation to you, it is the intention of the undersigned to commence an action thereon.
